This covered the economic attack on UK businesses and their owners. I being one, evidence in the intelligence gathering file INT/06A1/0004545/21.

GMCA and their controlling parties have subscribed to the EU/ UN Sustainability goals without a professional level of detailed investigation or risk assessment that is required to identify that you have assisted in destroying the UK economy and endorsed the attack on UK residents in this case specifically Greater Manchester in keeping with the WEF initiative of The Great Reset. 6. You may be unaware of China's grooming of British elites through the 48 Group as well as the dissemination of propaganda on behalf of the CCP by the World Health Organization, as well as subversion by infiltration through common purpose agents embedded in the NHS, NMC, BBC, PHE, OFCOM and in various institutions and Councils that have been caught out fabricating and overstating the virus statistics. GMCA failed to provide statistics when asked, by design and supported the treasonous narrative.
7. SAGE and its collaborators have set out to terrorize the UK population while exposing the people to the Chinese propaganda from WUHAN causing mass fear, alarm and distress as people watched the Vaccine/ 5G weapon tests, thus causing mass casualties and a death count that will rise exponentially globally.

There are concerted efforts by many in organisations to pervert and conceal the published peer reviewed science as well as ridicule and remove scientists who disagree with their falsified narrative while presenting to the media pseudo-science, all part of their terrorist propaganda to wage a memetic war of disinformation via social media and the national press in order to discredit the main scientific consensus on the dangers of untested unlicensed uninsurable technologies. This is in breach of the law.
9. We have and now you have the Prima Facie evidence of these crimes against the people within the planned terroristic agenda supported by this and your twisted Government machine, which includes strategies which until now you may not have been aware of. These political strategies are in breach of the 2000 Terrorism Act and part 1 of the 2006 Terrorism Act. Exhibit J.

Agents of the planned agenda, have falsified Death Certificates and Corona Virus statistics using the PCR test that both the official scientists relevant ministers and test manufacturers have admitted does not even establish the presence of the 'Virus'. Please make sure you have all the documentation with you for the 13<sup>th</sup> January as we will be asking questions of the claimant once confirmed by name based upon the intelligence now in your possession also of GMP within the intelligence gathering file. INT/06A1/0004545/21 who have prevented justice from taking place.

As your email for M19 legal team wouldn't appear to work when submitting mails we will copy in Chief Constable Stephen Watson as he will be required to enforce the warrants raised alternatively the men and women of Greater Manchester will have to take up their constitutional duties to protect themselves and fellow Mancunians from what is about to follow if allowed.

Again we still need GMP's crime number and reopening of CYCLOPS 1146/12 which had the critical evidence of the economic destruction methods carried out by Central Government, financial regulators, Police and Bankers.

These were covered up during 2012 by forces who we now know were instructed via HMRC and HM Treasury. Hence the reluctance to have questions raised by MP's Mike Kane of John Glen Treasury after 16.10. 2018 in the House of Commons, Westminster.
